REGULATION OF THE GOVERNMENT

of the Slovak Republic

of 11 August 2010,

amending Regulation of the Government of the Slovak Republic No. <u>581/2006 Coll.</u> on the System of Mandatory Controls for the Safe Operation of Ro-Ro Transit Ships and High Speed Personal Ships in Regular Transportation

The Government of the Slovak Republic pursuant to Article 2 paragraph 1 letter j) of Act No. 19/2002 Coll. establishing the conditions for the issue of approximation regulations of the Government of the Slovak Republic shall enact:

Article I

Regulation of the Government of the Slovak Republic No. <u>581/2006 Coll.</u> on the System of Mandatory Controls for the Safe Operation of Ro-Ro Transit Ships and High Speed Personal Ships in Regular Transportation shall be amended as follows:

- 1. In Article 1 paragraph 1, the words "and rights of the Ministry of Transportation, Post Offices and Telecommunications of the Slovak Republic (hereinafter referred to as the "Ministry") to conduct, participate or cooperate in investigating maritime disasters in this transportation" are deleted.
- 2. In Article 2 letter I), the words "a substantially interested Member State" are replaced by the words "a Member State with substantial interest".
 - 3. In Article 2, the letters m) and n) are deleted.

The current letter o) shall become the letter m).

- 4. In Article 3 letter a), the words "the Ministry" are replaced by the words "the Ministry of Transportation, Post Offices and Telecommunications of the Slovak Republic (hereinafter referred to as the "Ministry")".
- 5. In Article 4 letter b), the words "a substantially interested Member State" are replaced by the words "a Member State with substantial interest" and the words "pursuant to Article 11" are deleted.
 - 6. Article 11 is deleted.
- 7. The words "maritime disaster" in all forms in the whole text of the Government Regulation are replaced by the words "maritime accident or maritime exceptional event" in the respective form.
 - 8. Article 12 reads as follows:

"Article 12

With this Government Regulation, legally binding acts of the European Union listed in Appendix No. 3 are transposed and executed.".

- 9. The title of Appendix No. 3 reads: "List of transposed and executed legally binding acts of the European Union".
- 10. Appendix No. 3 is supplemented by Point 3, which is:
- "3. Directive 2009/18/EC of the European Parliament and of the Council of 23 April 2009, establishing the fundamental principles governing the investigation of accidents in the maritime transport sector and amending Directive 1999/35/EC of the Council and Directive 2002/59/EC of the European Parliament and of the Council (OJ EU L 131, 28.5.2009)."

Article II

This Government Regulation shall come into effect on 1 December 2010.
