The project is not likely to have significant effects on a site of nature conservation importance on the following grounds:

Planned highway starts at the end of planned section of the R1 highway Selenec - Beladice. It starts on crossroads at the end of the Tesárske Mlyňany village. Dexatory arc deflects from existing 1/65 road. It proceeds across the River of Žitava, to the south from gardens with agricultural areas and next through the valley of the Rivers Širočina and Bokovka and across the River of Olichovský potok. At the end of this section the planned route is led by existing 1/65 road. This part ends with lining up to the existing stage R1 Hronský Beňadik – Nová Baňa. There are no Natura 2000 sites (SCI – sites of Community importance and SPA – special protected areas) close to the involved area. Nearest SCI the Hodrušská hornatina (SKUEV0263) is located approximately 5.3 km south east from planned section of the highway. Detailed situation is specified on enclosed map. All project activities have been approved according to the national legislation (territorial planning or building permit procedure) and to all of them the official opinion from the involved nature and landscape protection Authority was needed.

Therefore an appropriate assessment required by Article 6 (3) of Directive 92/43/EEC was not deemed necessary.

Following an appropriate assessment, according to Art. 6(3) of Directive 92/43/EEC, the project will not have significant negative effects on a site of nature conservation importance.
