The project is not likely to have significant effects on a site of nature conservation importance on the following grounds:

The Project is aimed to continue building the D1 highway in next section. This section is connected to the planned D1 Višňové - Dubná skala highway and proceeds to the next planned section of the D1 Turany - Hubová highway. The route is mainly led through the open spaces, it is close to residental areas in Turčianske kľačany, Martin - priechod and in Turany. In Sučany it is led between the River of Váh and the rail. Planned section of the highway is not situated inside the Natura 2000 sites (SCI - sites of community importance and SPA - special protected areas). Nearest SCI is the SKUEV0252 Malá Fatra (approximately 0.23 - 1.4 km away from planned highway) and SKUEV0238 Veľká Fatra (approximately 2.6 km away from planned highway). Distance from the closest SPA SKCHVU013 Malá Fatra is app. 0.23 - 2.5 km and from the SKCHVU033 Veľká Fatra app. 2 km. Detailed localization and situation is specified on enclosed map.

All project activities have been approved according to the national legislation (territorial planning or building permit procedure) and to all of them the official opinion from the involved nature and landscape protection Authority was needed.

Therefore an appropriate assessment required by Article 6 (3) of Directive 92/43/EEC was not deemed necessary.
