The Project is aimed building of other section of the D1 highway. Planned section connects prepared segment of the highway Dubná Skala – Turany, continues to the south-east, in the area of the Šútovo quarry is leaded by bridges and than through the deep notch. Then it bridges over the railway, I/18 road and the Váh River. It continues along the left bank of the Váh River on flyovers, later drive in the Rojkov tunnel (lenght 1.800 m) and then bridges over the railway again, the Váh River and the I/18 road and connects other planned segment of the D1 Hubová – Ivachnová highway.

Planned highway crosses via 3 bridges three times sites of Community importance SKUEV0253 Ricka Váh, passes through the SKUEV0252 Malá Fatra and SKUEV0238 Veľká Fatra sites of Community importance and also the SKCHVU013 Malá Fatra special protection area.

An evaluation form required for the appropriate assessment was developed as a basis for the official opinion under §28a of the Act No. 543/2002 on Nature and Landscape Protection Coll. as amended. The official opinion states, that the project will not have any significant effect on the Natura 2000 sites. There is also the SKUEV0254 Močiar situated close to the planned highway at distance about 150 m to the north. Situation is specified on the enclosed map.

All project activities have been approved according to the national legislation (territorial planning or building permit procedure) and to all of them the official opinion from the involved nature and landscape protection Authority was needed.


