of the Ministry of Transport, Construction and Regional Development of the Slovak Republic

of 30. November 2011,

changing and amending Decree of the Ministry of Transport, Construction and Regional Development of the Slovak Republic No. 558/2009 Coll., establishing a list of construction products that must be labelled, systems of conformity attestation, and details of the use of conformity markings

Pursuant to Section 17(4) of Act No. 90/1998 Coll., on construction products, as amended, the Ministry of Transport, Construction and Regional Development of the Slovak Republic enacts:

Article I

Decree of the Ministry of Transport, Construction and Regional Development of the Slovak Republic No. 558/2009 Coll., establishing a list of construction products that must be labelled, systems of conformity attestation, and details of the use of conformity markings, is changed and amended as follows:

- 1. Section 5(1) reads:
 - "(1) The conformity marking and attendant information shall be placed in a visible, legible and indelible manner on the construction product or to a label affixed to it. If the nature of the construction product does not allow or guarantee this, the conformity marking and attendant information shall be placed on the construction product's packaging or accompanying documentation."
- 2. Following Section 7, Section 7a is inserted, which including its heading reads as follows:

"Section 7a Transitory provisions for changes effective from 1 January 2012

Proving the conformity of products affected by this decree shall be performed in the prescribed manner until 1 June 2012."

3. Following Section 9, Section 9a is inserted, which including its heading reads as follows:

"Section 9a Final provisions for changes effective from 1 January 2012

This decree has been passed in accordance with a legally binding act of the European Union in the area of technical standards and technical regulations.³⁾".

4. In Annex No. 1, product groups 503 and 504 read:

"0503	Gravel for no	onagglutinat	e materials and hydraulically	By purpose:

5. Footnote 10a) reads:

"10a) STN 73 6114:1997 Road pavement. Basic provisions for design."

- 6. In Annex No. 1, the name of product group 0515 reads:
 - "Arrest systems for protection of pedestrians".
- 7. In Annex No. 1, in product group 0517, in the group name the word "reflective" is replaced by the word "directional".
- 8. In Annex No. 1, the name of product group 0518 reads:
 - "Prefabricated horizontal traffic signs and retroreflective road markers for road surface marking".
- 9. In Annex No. 1, after product group 0705, product group 0706 is inserted, which reads:

"0706 Pı	Prefabricated bridge cornice sections		2+"

- 10. In Annex No. 1, the name of product group 2403 reads:
 - "Waterproof roof systems applied by pouring asphalt or foam spraying".
- 11. In Annex No. 1, the following words are appended to the name of product group 2605: "between premises with the same environment".
- 12. In Annex No. 1, in product group 2903, conformity attestation system "2+" is replaced by system "3".
- 13. In Annex No. 1, in product group 3102, conformity attestation system "2+" is replaced by system "4".
- 14. In Annex No. 1, after product group 3802, product group 3803 is inserted, whose name reads:
 - "Low-voltage electrical switchgear for distribution of power, control and communication".
- 15. In Annex No. 2, for point four, the footnote for a) reads:
- "a) The shape and size of the letters of the EC marking are governed by Annex II to Regulation (EC) No 765/2008 of the European Parliament and of the Council of 9 July 2008 setting out the requirements for accreditation and market surveillance relating to the marketing of products and repealing Regulation (EEC) No 339/93. The shape and size of the Slovak C_{SK} conformity marking, its manner of production and protection from reuse is governed by Sections 18 and 19 and the annex to Act No 264/1999 Coll., on technical requirements for products and on conformity assessment, and on changes and amendments to some Acts, as amended by Act No. 436/2001 Coll."

Article II

This decree shall take effect on 1 January 2012.
